

International Meeting Recap / Chapter News

The Annual International Meeting of the 99s was held virtually via Zoom on July 10th.

Announcement - next year the annual meeting will be held in person in Charleston SC, July 6-10!! Probably hybrid with attendance via Zoom also.

All of the reports and the package of conference documents can be found on the international website (ninety-nines.org). Sign in to the members website and go to the library section then to conference to find them.

There were a total of 1261 delegates, representing just over 6000 members, and only 670 delegate votes were actually present and used at the meeting. That is just about 50% of the delegate votes used. Where were the other 50%? The Maryland Chapter had 8 delegate votes, and they were all cast for each By-Law.

In summary, the meeting consisted of the presentation of many reports, including the President's Report, the Secretary's report, the four trusts (AE Birthplace, AE Scholarship, 99s Museum of Women Pilots, 99s Endowment Fund), all of which are available in the members section of the website. The By-Laws Committee presented 13 amendments for consideration, and all 13 passed by large margins. The 13th amendment was to change from the delegate system to a One Member One Vote (OMOV) system. There was considerable discussion about the implementation as proposed. One issue that will probably be re-visited was the issue of using proxy votes for a member who does not attend. Proxy votes will be allowed if the meeting is only in person, but not if the meeting is hybrid to include on-line attendance.

New trustees and Board Members were installed. The 2021 International Awards were presented.

And it only took three and a half hours!!

Over the years I have attended several International meetings, and in-person is a lot more fun. Let's get a crowd to go to Charleston, SC, next July!!!


NINETY-NINES MARYLAND CHAPTER APRIL NEWSLETTER


